Subject: Commitment u-turn on export of hazardous chemicals banned in the EU

Dear President von der Leyen, Executive Vice-President Šefčovič, and Commissioner Sinkevičius.

We are alarmed and disappointed to learn that the European Commission plans to renege on its commitment to deliver on its announcement under the <u>Chemicals Strategy for Sustainability</u> to lead by example and, in line with international commitments, ensure that hazardous chemicals banned in the European Union are not produced for export.

We strongly urge you to reconsider, and to adopt an ambitious legislative proposal by March 2024 at the latest.

More than 326 civil society organisations from across the globe, institutions and trade unions delivered a <u>Joint Statement</u> to the European Commission in December 2022 demanding a ban on the export of hazardous chemicals that are forbidden in the EU. Furthermore, 267,000 people have now signed an export ban petition to Commissioner Sinkevičius, and more than 2,400 EU citizens also contributed feedback to the public consultation earlier this year.

These dangerous chemicals have been banned in the EU to protect human health and the environment. They are currently produced and exported by EU countries to third countries, taking advantage of weaker regulations, and have devastating impacts on local communities.

Not only do these hazardous chemicals harm people and ecosystems outside the EU, but they also end up in Europe, in the form of residues in food imports.

We remain at your disposal for a meeting to further exchange on this urgent matter.
